RESOLUTION 2023-21**

A RESOLUTION ACCEPTING THE LOW BID OF \$127,353.60 SUBMITTED BY ANGELO BENEDETTI, INC. FOR THE 2023 CANADA, GLENWOOD, MAPLE AND HERALD PAVING PROJECT, AUTHORIZING THE MAYOR AND FISCAL OFFICER TO ENTER INTO A CONTRACT FOR SAID IMPROVEMENTS, AND DECLARING AN EMERGENCY.

WHEREAS, this Council authorized advertisement for bids for the 2023 Canada, Glenwood, Maple and Herald Paving Project by passage of Resolution 2023-11 on March 21, 2023; and

WHEREAS, the bids were publicly opened and read at 11:00 a.m. on May 15, 2023 as set forth in the attached bid tabulation (“Exhibit A”); and

WHEREAS, the bid of \$127,353.60, submitted by Angelo Benedetti, Inc., is the lowest and best bid among those submitted for the 2023 Canada, Glenwood, Maple and Herald Paving Project; and

WHEREAS, the Council of the Village of Mantua now wishes to declare Angelo Benedetti, Inc. to be the lowest and best bidder for the 2023 Canada, Glenwood, Maple and Herald Paving Project, and to accept their bid and authorize the Mayor and Fiscal Officer to enter into a contract for said improvements.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. The Council of the Village of Mantua hereby accepts the bid of \$127,353.60 submitted by Angelo Benedetti, Inc. as the lowest and best bid submitted for the 2023 Canada, Glenwood, Maple and Herald Paving Project.

SECTION 2. This Council hereby authorizes the Mayor and Fiscal Officer to enter into a contract with Angelo Benedetti, Inc. of Bedford, Ohio for said improvements.

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 4. This Resolution is hereby declared an emergency measure in order to expedite execution of the 2023 Canada, Glenwood, Maple and Herald Paving Project, and shall become effective immediately upon proper passage by this Council.
