

**Village of Mantua, Ohio**  
**ORDINANCE 2023-23**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2023  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, appropriations in the General Fund #1000 and Road and Bridge Levy Fund #2012 must be increased in order to pay for the 2023 Road Paving Project and the West Franklin Street Phase I project; and

**WHEREAS**, appropriations in the Buchert Park Walking Trail Fund #4201 must be increased in order to pay expenses related to Phases IV and V of the project.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustments to the 2023 Village Appropriations:

**SECTION 3.** This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
