

**Village of Mantua, Ohio  
RESOLUTION 2023-25**

**A RESOLUTION DECLARING THE 2006 CHEVROLET SILVERADO TRUCK  
NO LONGER NEEDED FOR MUNICIPAL PURPOSES, AUTHORIZING THE  
VILLAGE ADMINISTRATOR TO DISPOSE OF THIS EQUIPMENT BY  
INTERNET AUCTION, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Village of Mantua owns a 2006 Chevrolet Silverado Truck, VIN# 1GBHC24U06E103261, which is nearing the end of its useful life; and

**WHEREAS**, the estimated value of this item is in excess of \$1,000.00; and

**WHEREAS**, this Council has passed Resolution 2023-24, pursuant to Ohio Revised Code Section 721.15(D), which provides for the sale of "personal property, including...road machinery, equipment, tools, or supplies, which is not needed for public use, or is obsolete or unfit for the use for which it was acquired, by internet auction."

**NOW THEREFORE BE IT RESOLVED** by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** It is hereby determined that the 2006 Chevrolet Silverado Truck, VIN# 1GBHC24U06E103261 is obsolete and no longer fit for public use by the Village of Mantua.

**SECTION 2.** This Council hereby authorizes the Village Administrator or his designee to initiate an internet auction at [Govdeals.com](http://Govdeals.com), seeking bids for the 2006 Chevrolet Silverado Truck, VIN# 1GBHC24U06E103261 owned by the Village. Said auction shall have a duration of fourteen days and shall have a starting price of One Thousand Dollars (\$1,000.00).

**SECTION 3.** The Village shall require payment in full at the completion of the auction, and that the vehicle shall be collected by the winning bidder. The Village shall not agree to deliver the vehicle.

**SECTION 4.** The Village shall require that all moneys collected as a result of the auction shall be payable by transfer into the Village of Mantua bank account on record, per [Govdeals.com](http://Govdeals.com) standard policy.

**SECTION 5.** The net proceeds from the sale of the equipment shall be deposited as follows: 20.20% in the Cemetery Fund #2031, 15.15% in Streets Fund #2011 and 64.65% in General Fund Parks #100-320.

**SECTION 6.** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.
