ORDINANCE 2023-29

AN ORDINANCE ESTABLISHING THE SALARY OF THE MAYOR OF THE VILLAGE OF MANTUA, OHIO FOR THE TERM COMMENCING JANUARY 1, 2024 AND THEREAFTER, AND DECLARING AN EMERGENCY.

WHEREAS, the Finance Committee has recommended, and this Council deems it necessary, to increase the salary for the Mayor of the Village of Mantua, Ohio for the term commencing January 1, 2024 and thereafter.

NOW, THEREFORE, be it Ordained by the Council of the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. Effective for the term commencing January 1, 2024 and thereafter until properly amended by action of Council, the annual salary of the office of Mayor of the Village of Mantua is hereby established at Fifteen Thousand Six Hundred and 00/100 dollars (\$15,600.00).

SECTION 2. The salary of the Mayor of the Village of Mantua, Ohio shall be paid in the amount of One Thousand Three Hundred and 00/100 dollars (\$1,300.00) per month on the first payday of each month in accordance with the established pay schedule for the Village of Mantua, Ohio.

SECTION 3. Existing Section 131.02(c) of the Village of Mantua Codified Ordinances is hereby repealed.

SECTION 4. Section 131.02(c) of the Village of Mantua Codified Ordinances is hereby enacted to read as follows:

- (c) (1) For the terms commencing January 1, 2016 and January 1, 2020, the compensation for the position of Mayor will be eight thousand four hundred dollars (\$8,400.00) per year, payable in equal monthly installments of seven hundred dollars (\$700.00).
- (2) For the term commencing January 1, 2024 and thereafter until properly amended by action of Council, the annual compensation for the position of Mayor shall be fifteen thousand six hundred and 00/100 dollars (\$15,600.00), payable in equal monthly installments of one thousand three hundred and 00/100 dollars (\$1,300.00).

SECTION 5. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 6. This Ordinance is hereby declared an emergency measure in order that the compensation for the mayor of the Village of Mantua be established for the ensuing term of office at a meeting held not later than five days prior to the last day fixed by law for filing as a candidate for such office as required by Ohio Revised Code section 731.13.
