

**Village of Mantua, Ohio
RESOLUTION 2023-48**

**A RESOLUTION RESCINDING RESOLUTION 2023-24, AND EXPRESSING THE
INTENT OF THE COUNCIL OF THE VILLAGE OF MANTUA, OHIO TO DISPOSE
OF PROPERTY OWNED BY THE VILLAGE WHICH IS NO LONGER NEEDED FOR
PUBLIC USE BY INTERNET AUCTION THROUGH EDINBURG AUCTION SALES
OF ROOTSTOWN, OHIO FOR THE REMAINDER OF THE YEAR 2023, AND
DECLARING AN EMERGENCY.**

WHEREAS, the Village of Mantua from time to time seeks to dispose of property which is no longer needed for public use, or otherwise obsolete or unfit for the purpose for which it was acquired; and

WHEREAS, the proceeds from a sale of such property will be of use to the Village; and

WHEREAS, Ohio Revised Code Section 721.15(D), provides for the sale of "personal property, including motor vehicles acquired for the use of municipal officers and departments... by internet auction" and that such legislation shall be in place annually; and

WHEREAS, this Council believes that the use of internet auctions for such purpose will provide an improved level of exposure for such auctions, and an increased level of bids for such property over traditional methods of bid-seeking, thereby increasing the revenue of the Village; and

WHEREAS, the Village Administrator has recommended the use of Edinburg Auction Sales, Inc. for such auctions rather than Ebay or GovDeals.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Mantua, two thirds or more of the members elected thereto concurring, that:

SECTION 1. Resolution 2023-24, approved by this Council on June 20, 2023, is hereby rescinded.

SECTION 2. This Council hereby expresses its intent to dispose of personal property, including motor vehicles acquired for the use of municipal officers and departments, by internet auction during the calendar year 2023.

SECTION 3. All such auctions shall be arranged by the Village Administrator or his designee, and conducted on behalf of the Village of Mantua by Edinburg Auction Sales, Inc., 4029 State Route 14, Rootstown, Ohio 44272, 330-325-2966. (edinburgauction.com) .

SECTION 4. All such auctions shall endure for no less than ten (10) days.

SECTION 5. The Fiscal Officer of the Village of Mantua is hereby authorized and directed to publish, twice, and between ten and twenty days apart, notice of the Council of the Village of Mantua's intent to sell unneeded property, owned by the Village, by internet auction.

SECTION 6. The Fiscal Officer is further authorized and directed to ensure that said

notice is also posted throughout the year in a conspicuous place at the Village Offices, and made part of the internet website of the Village of Mantua, as required by law.

SECTION 7. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 8. This Resolution is hereby declared an emergency measure, in order to authorize the use of Edinburg Auction Sales, Inc. at the earliest time possible, and shall become effective immediately upon proper passage by Council.
