

**Village of Mantua, Ohio
RESOLUTION 2023-49**

A RESOLUTION DECLARING VARIOUS ITEMS OF PERSONAL PROPERTY OWNED BY THE VILLAGE OF MANTUA TO BE NO LONGER NEEDED FOR MUNICIPAL PURPOSES, AUTHORIZING THE VILLAGE ADMINISTRATOR TO DISPOSE OF THIS EQUIPMENT BY INTERNET AUCTION, AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Mantua owns a number of items, previously used by the Service Department, which are nearing the end of their useful life, have become too costly to repair, or are otherwise no longer fit or needed for municipal purposes; and

WHEREAS, the estimated value of many of these item is in excess of \$1,000.00; and

WHEREAS, this Council has passed Resolution 2023-48, pursuant to Ohio Revised Code Section 721.15(D), which provides for the sale of "personal property, including...road machinery, equipment, tools, or supplies, which is not needed for public use, or is obsolete or unfit for the use for which it was acquired, by internet auction."

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. It is hereby determined that the following items of personal property are obsolete and/or no longer fit for public use and/or no longer needed for municipal purposes by the Village of Mantua:

- 2000 Blue Ford Tractor
- Aerator
- Echo Backpack Leaf Blower
- Harbor Freight Cement Mixer
- 72-Inch PTO Finish Mower
- Agri-Fab Yard Leaf Vacuum Brand Unknown (Black)
- Tow Behind Commercial Leaf Vacuum Blown Motor, Brand Unknown (Red)
- Little Giant Wheeled Leaf Blower
- Toro 20-Inch Self Propelled Push Mower
- Yard Machine 21-Inch Snowblower
- 2012 Ford F350 VIN 1FTRF3B6XCEA41770
- 2002 Freightliner VIN 1FVABSBV32HJ52057

SECTION 2. This Council hereby authorizes the Village Administrator or his designee to arrange for internet auctions to be conducted by Edinburg Auction Sales, Inc., seeking bids for the items listed in Section 1, above, pursuant to the terms of Resolution 2023-48.

SECTION 3. The net proceeds from the sale of the equipment shall be deposited *pro rata* into the funds from which the equipment was originally purchased.

SECTION 5. This Resolution is hereby declared an emergency measure, in order to permit the disposition of obsolete equipment at the earliest possible time, and shall become immediately effective upon proper passage by this Council.
