ORDINANCE 2024-26

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2024
VILLAGE OF MANTUA APPROPRIATIONS AND DECLARING AN EMERGENCY.**

WHEREAS, appropriations must be increased in General Fund 1000 in order to account for the loan amount received for the new police vehicle; and

WHEREAS, appropriations must be amended in Funds 2021 and 2101 in order to maintain consistency with anticipated revenues and to pay for the 2024 chip and seal program; and

WHEREAS, appropriations in Cemetery Fund 2031 must be increased in order to pay expenses approved for funding through the Delia Thompson Trust in 2023 and 2024.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. Council does hereby authorize the following adjustments to the 2024 Village of Mantua Appropriations:
