

**Village of Mantua, Ohio  
ORDINANCE 2024-41**

**AN ORDINANCE AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2024  
APPROPRIATIONS AND DECLARING AN EMERGENCY.**

**WHEREAS**, appropriations in the General Fund #1000 need to be increased to account for the vandalism occurred at the River Trail; and

**WHEREAS**, additional appropriations in the General Fund need to be increased in the total amount of \$6,110.96 to fund this item; and

**WHEREAS**, appropriations in the American Rescue Plan Fund #2151 need to be increased to use the fund prior to the end of the year; and

**WHEREAS**, additional appropriations in the American Rescue Plan Fund #2151 need to be increased in the total amount of \$23.04 to fund this item; and

**WHEREAS**, appropriations in the Shade Tree Fund #9901 need to be increased to use the fund prior to the end of the year; and

**WHEREAS**, additional appropriations in the Shade Tree Fund need to be increased in the total amount of \$1,961.58 to fund this item.

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Council does hereby authorize the following adjustments to the 2024 Village of Mantua Appropriations:
