ORDINANCE 2024-46

**AN ORDINANCE AMENDING CHAPTER 121.03 RULES OF COUNCIL OF THE
CODIFIED ORDINANCES OF THE VILLAGE OF MANTUA.**

WHEREAS, Council is in the process of deleting Chapter 147 Shade Tree Commission of the Codified Ordinances of the Village of Mantua in proposed Ordinance 2024-42; and

WHEREAS, Chapter 121.03 Council rules have references to the Shade Tree Commission; and

WHEREAS, Council desires to remove any references to the Shade Tree Commission.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Mantua, Ohio that:

SECTION 1. Chapter 121.03 Article XIII, Section (3) and (5)(a) of the Codified Ordinances of the Village of Mantua are hereby deleted.

SECTION 2. Article XIII is amended and renumbered as follows:

- (1) Planning Commission, in accordance with the Village of Mantua Code of Ordinances Section 143.01, was established in accordance with Ohio R.C. 713.01.

The Planning Commission shall consist of the Mayor, one member of Council, to be elected thereto for the remainder of the term of such member of Council, and three citizens of the Village, as provided for in Section 143.01(b), which three citizens of the Village are appointed by the Mayor with the approval of Council.

- (2) Cemetery Board is in accordance with Ohio Revised Code and Village of Mantua Code of Ordinances Chapter 145.
- (3) Parks Board of Commissioners is in accordance with the Village of Mantua Code of Ordinances Chapter 951.

The Parks Board of Commissioners in accordance with Village of Mantua Code of Ordinances Section 951.01 shall consist of five (5) members appointed by Council, two (2) of whom shall be members of Council, with the other three (3) members being residents of the Village.

The Parks Board of Commissioners shall have the control and management of the Village Park and its facilities and all improvements and additions thereto, in accord with Section 951.02 of the Village of Mantua Code of Ordinances. (Ord. 2011-81. Passed 11-8-11.)

- (4) Alternate members.
- (a) The Mayor with the approval of Council may name alternate members to the Board of Park Commissioners.
 - (b) Alternate members shall be appointed annually, and shall be residents of the Village of Mantua. Alternates may be members of Council.
 - (c) In the event a regular member of a commission is absent for any reason or a seat otherwise vacant, the alternate member shall serve during such absence or vacancy. When serving in the place of a regular member of a commission, an alternate member shall have the same powers and perform the same duties as a regular member of the Commission.

SECTION 3. Chapter 121.03 Article XIII as it existed prior to the effective date of this Ordinance is hereby repealed.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were adopted in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared an emergency measure, for the reason that it is necessary to remove the requirements from the Codified Ordinances, and therefore shall be effective immediately upon its passage by at least two-thirds of the members elected to the Mantua Village Council.
