ORDINANCE 2024-49

AN ORDINANCE ESTABLISHING MEETING DATES AND TIMES FOR VILLAGE COUNCIL AND THE VARIOUS COMMITTEES AND COMMISSIONS OF THE VILLAGE OF MANTUA, AND DECLARING AN EMERGENCY.

WHEREAS, the Council has recommended changes to the meeting dates for various committees and commissions of the Village of Mantua; and

WHEREAS, this Council wishes to approve an Ordinance setting forth the dates and times of all Village meetings.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. Council does hereby authorize the following dates and times for the Village of Mantua’s regularly scheduled public meetings beginning January 1, 2025:

Meeting(s)	Day	Time
Cemetery Committee	First Tuesday of April and September	Beginning at 6:00 pm
Parks Board	First Tuesday of March, May, July and September	6:00 pm
Service Committee	First Tuesday of each month	6:00 pm or following Cemetery and Parks meetings
Safety Committee	Second Tuesday of each month	6:00 pm
Planning Commission	Second Tuesday of each month	6:30 pm
Finance Committee	Wednesday before the monthly Village Council meeting	6:00 pm
Landmarks Commission	Second Saturday of February, April, June, August, October, December	10:00 am
Village Council	Third Tuesday of each month	6:00 pm

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 3. This Ordinance is hereby declared to be an emergency measure, in order to establish or change meeting dates and times for 2025 and beyond, and for that reason this Ordinance shall take effect after proper passage by Council on January 1, 2025.
