

**Village of Mantua, Ohio**  
**ORDINANCE 2024-56**

**AN ORDINANCE REQUIRING ALL VILLAGE OF  
MANTUA EMPLOYEES AND ELECTED OFFICIALS TO  
COMPLETE FRAUD REPORTING AND TRAINING, AND  
DECLARING AN EMERGENCY.**

**WHEREAS**, the 135<sup>th</sup> General Assembly amended O.R.C. Section 117.103 requiring the Auditor of State to confirm during the course of an audit, that public employees and elected officials have completed fraud reporting and training; and

**WHEREAS**, this Council desires to amend the Mantua Employee Handbook to require employees to take the Auditor of State’s Fraud Reporting and Training; and

**WHEREAS**, this Council is desirous of requiring all elected officials to take the Auditor of State Fraud Reporting and Training; and

**NOW, THEREFORE, BE IT ORDAINED** by the Village of Mantua, Ohio, two-thirds or more of the members elected thereto concurring, that:

**SECTION 1.** Section 2.3 E Employment Eligibility of the Village of Mantua Employee Handbook is hereby enacted as follows:

Section 2.3 E

All employees are required to complete the Auditor of State’s Fraud Reporting and Training training within thirty (30) days of employment and shall be required to be trained every 4 years.

**SECTION 2.** All elected officials are required to complete the Auditor of State’s Fraud Reporting and Training within thirty (30) days of taking office and shall be required to be trained every 4 years.

**SECTION 3.** Section 131.03 Mayor is hereby enacted as follows:

**SECTION 131.03 FRAUD TRAINING**

The Mayor shall complete the Auditor of State’s fraud reporting and training within 30 days of taking office and shall be required to be trained every 4 years.

**SECTION 4.** Section 121.05 Council is hereby enacted as follows:

**SECTION 121.05 FRAUD TRAINING**

The Members of Council shall complete the Auditor of State’s fraud reporting and training within thirty (30) days of taking office and shall be required to be trained every 4 years.

**SECTION 5.** It is hereby found and determined that all formal action of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this

Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in a meeting open to the public in compliance with all legal requirements, including section 121.22 of the Ohio Revised Code.

**SECTION 6.** This ordinance is hereby declared an emergency measure in order to implement Ohio Revised Code Section 117.103 requirements for the Village of Matua at the earliest time possible, and shall become effective immediately upon proper approval by this Council.
