

**Village of Mantua, Ohio
RESOLUTION 2025-04**

**A RESOLUTION AUTHORIZING THE PURCHASE OF A SALT SPREADER, AND
DECLARING AN EMERGENCY.**

WHEREAS, the Service Committee has recommended the purchase of Snowex Renegade P220A Poly 81470 salt spreader; and

WHEREAS, the Village of Mantua participates in the Source Well pricing which provides cost savings for purchasing goods and services; and

WHEREAS, the salt spreader, through delivering dealer Marshall Power Equipment, LLC of Chesterland, Ohio, has provided a product quotation which meets the Village bidding requirements.

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Mantua, two-thirds or more of the members elected thereto concurring that:

SECTION 1. The Fiscal Officer and the Village Administrator are hereby authorized to enter into an agreement to purchase a Snowex Renegade P220A Poly 81470 salt spreader from Marshall Power Equipment, LLC of Chesterland, Ohio, for the total cost not to exceed \$10,111.70 including options as set forth in the Sales Contract attached hereto as Exhibit A.

SECTION 2. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of the Council, and that all deliberations of this Council and any of its committees that resulted in such formal actions were adopted in meetings open to the public, in compliance with Section 121.22 of the Ohio Revised Code.

SECTION 3. This Resolution is declared an emergency measure, in order to expedite the acquisition of equipment necessary for the Service Department to maintain the various facilities and properties of the Village at the earliest possible time, and shall become immediately effective upon its passage by two thirds or more of the members of Council.
