ORDINANCE 2025-06

AN ORDINANCE REPEALING ORDINANCE 2025-03 AND AUTHORIZING CERTAIN ADJUSTMENTS TO THE 2025 APPROPRIATIONS AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance 2025-03 authorizing certain adjustments to the 2025 appropriations is hereby revoked; and

WHEREAS, appropriations in the General Fund #1000 need to be increased to account for the Service Department purchases; and

WHEREAS, additional appropriations in the General Fund need to be increased in the total amount of \$15,583.04 to fund these items; and

WHEREAS, appropriations in the Capital Projects Fund #4901 need to be increased to account for the Service Department purchases; and

WHEREAS, appropriations in the Capital Projects Fund need to be increased in the total amount of \$10,000.00 to fund these items.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Mantua, Portage County, Ohio, two-thirds or more of the members elected thereto concurring, that:

SECTION 1. Ordinance 2025-03 is hereby repealed.

SECTION 2. Council does hereby authorize the following adjustments to the 2025 Village of Mantua Appropriations:

SECTION 3. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure, necessary to maintain correct accounting practices, to pay the current and imminent financial obligations of the Village and to prevent expenditures from exceeding appropriations, and for that reason this Ordinance shall take effect immediately upon proper passage by Council.
