"FROM THE MAYOR'S DESK"

STATE OF THE VILLAGE OF MANTUA ADDRESS

2014 has been a very productive year for the Village of Mantua. This is due to Village Council, the Village Administrator, the Village Clerk, all of our employees and myself working so well together on the many projects that were completed in 2014.



We applied for an OPWC grant in partnership with the Crestwood School District to install a new sewer line, replacing the lift station at the Middle School. The grant was approved and the project was paid for with OPWC funds and matching/in kind funds contributed by Crestwood. This partnership worked out well for both the school and the Village. We look forward to another project with the school.

The Village partnered with the DMRC for an AMATS grant for sidewalks, curbing, relocation of a hydrant, and storm sewer catch basins on the south end of the Village. We also worked in tandem with ODOT's bridge and paving project. Our portion of the project was approximately \$136,000.00, the match and in-kind was paid by the DMRC, many of the south end property owners and the Village.



We applied for and were awarded an OPWC grant to repair or replace a total of 19 fire hydrants. The total project was for \$55,200.00 with a match of in-kind hours/and village funding of \$22,000.00 and funding from OPWC for \$33,200.00. We replaced 8 hydrants and repaired 11 hydrants.

We finally completed the work in September related to the EMA grant, which was awarded to repair damage caused by the storm on July 10, 2013; total project cost was \$108,282.93. EMA reimbursed the Village 75% of all eligible expenses. On this project we replaced sections of storm sewer lines that collapsed on Walnut, Reagan and Glenwood, replaced or rebuilt over 19 storm sewer catch basins, put in two head walls on Woodford, replaced a culvert on Main (with the assistance of ODOT). We did chip and seal or paving on four streets that had been compromised by the storm.

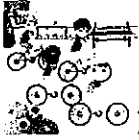
With funds from the Cemetery Trust we installed 450ft of drainage pipe and paved the entrance to the Cemetery, removed 6 trees that had become a hazard and started a tree replanting program.

We applied for and were awarded an OPWC grant to make improvements/up grades at the water and sewer plant. Those funds will be available this summer. This funding is for \$219,000.00. The break down in this is \$50,000.00 in a low interest loan, \$10,001.00 in local match and the rest in grant funding.



In November, the Village voters approved a five year, \$75,000 property tax levy for the specific purpose of street repair and replacement within the Village. We extend our sincere gratitude to the voters for giving us the opportunity to improve our streets in the coming years.

One of our major goals for 2015 will be to establish a paving schedule, in order to most effectively put these additional funds to use. We hope to begin with some of the smaller streets with a portion of the funding, and potentially apply for road work grants, using the tax revenue generated for any required matching funds. Prior to beginning any paving work, we will need to camera the infrastructure beneath the streets to make sure the water/sewer lines are in order so as to not pave then end up digging up a street. We intend to pursue infrastructure grants as well in order to make all of these projects come together in the most efficient way possible.



In 2015, we will also be looking into other grant opportunities for the Village, such as the SWIF grant program for retention basins and permeable pavement to help guard against flooding, and for grants for expanding and improving our trails, such as the Clean Ohio Trails Fund, the Recreational Trails Program, and Natureworks Funding.



A NOTE FROM JENNY



It has been awhile since I have updated our residents on our finances, so it is time! The economy appears to be stabilizing, and so are Mantua Village finances, with a lot of discipline. All of our funds continue to hold steadily in the black. Our gasoline bill this month is the lowest it has been since I started here in April of 2008. If this keeps up, Jack and I are going to start taking Sunday drives again to cool places.



Thanks to the generosity of the voters in town, the Service Department will be making arrangements to have a few of our roads, (or sections at a time) paved each year. Kate and Dave are working on a paving schedule based on street condition and use. The levy that you passed will generate about \$75,000 per year to be used for street improvements. In time, we will all enjoy nice, smooth streets.

Finance can get boring, so I would like to incorporate some fun into my article. For some of the mentionable holidays that are approaching, I have the following comments;

Project, Drug Free Schools



The Mantua Police Department has purchased another Canine, Diablo, who will be the first canine assigned for use in our school system.

The Project, Drug Free Schools, is to initiate and fund a narcotics canine unit within the Mantua Police Department, and to train our dog in narcotics, which will enable an officer with the Mantua Police Department in conjunction with the support of Crestwood School District to actively work with the school system to keep drugs out of our schools.



The dog and its trainer will be used not only for enforcement purposes but, also to increase police awareness and visibility. The canine team will be part of the partnership with Crestwood Schools assigned to the School Rescores Officer and will be used primarily in Crestwood School system. Diablo will perform search activities for controlled substances within the building and parking lots and to deter any drugs even being brought on the property. In addition the officer and canine will be part of a public relations and education tool.

The team will also be made available to other neighboring police departments and agencies for enforcement activities. The team will be used on a day-to-day basis during the school year to promote a drug free environment for our kids on a regular basis.



The purchase and funding of a canine team consists of two different parts. The first being the animal and the basic equipment needed to initiate the project, which has been done. We are still in need of additional funding for the second part, to provide a vehicle for transportation for the dog and handler.



The Mantua Police Department is seeking additional donations to fund the needed equipment and vehicle needed for the trained police dog. Any donation will help fund this important project and help keep our schools drug free. Persons with questions can contact the Mantua Police Department at 330-274-2251. Donations to this program will be used to maintain and equip a fully trained German Shepherd Police Dog and vehicle. 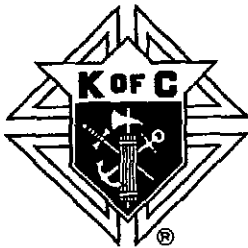

Even duct tape can't fix stupid ... but it can muffle the sound!

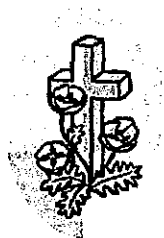
I'm going to retire and live off of my savings. Not sure what I'll do that second week.

Concerned Citizens Ohio, a grassroots group concerned about Class II injection wells in Portage County, is presenting a series of six informational topics before elected officials in Mantua and Shalersville for the next several months. Class II wells are for disposing of the hazardous waste brines that come from chemical fluids used in drilling oil and gas wells.

Mary Greer, a coordinator for the group, is appearing before the Mantua Village Council and the Shalersville Township trustees to provide data and research about the 18 active Class II wells now receiving toxic waste from PA and other states as well as from southeastern Ohio. Portage also has 8 newly permitted wells and 13 others that could be reopened for waste, allowing for many more barrels of the fluid waste to be brought to Portage.



In 2013, 2 million barrels of waste came to Portage, and 2014 will show even greater numbers.

Greer reports that according to the U.S. Congress, 750 chemicals identified in frack fluid are "of concern." 51 of these are known carcinogens. Greer's topics also cover research on well casing failure, health impacts for those living near injection wells, and the potential for aquifer contamination.

The economics of the waste wells is surprising too, since only the well owners make money from the wells by charging drillers a per barrel price for dumping here. Portage County receives no money, but bears the burden in terms of road repair, water quality problems, and property value losses.

Each topic is very short—only three minutes long—but is supported with handouts from the Ohio Department of Natural Resources, the federal government, and scientific white papers.

One member of the Streetsboro City Council, which has already heard all 6 topics, stated that this is information that every community needs. A Shalersville township employee described some of the facts presented as "staggering."



Greer believes this is a "need-to-know" issue and one of the greatest challenges of this decade. "The quality of our water affects our property values and ultimately our lives," she says. "We are not telling elected officials what to do. Concerned Citizens Ohio believes that people can decide for themselves when they have all the facts."

The series of six topics is also being presented in Franklin, Atwater, Brimfield, and Rootstown township trustees for the next months by other members of Concerned Citizens Ohio. Interested citizens can attend the periods for public comment in these jurisdictions as well as Mantua Village Council and Shalersville Township.

THE RIVER OF TIME

Did you know that Mantua Village has two blocks plus of buildings on The National Register of Historic Places? That recognition was gained in 1974, and you can see the application in its entirety online under OH_740016o6.pdf on the National Park Service website.



It mattered enough for someone to make the effort, and maybe at the time it was a high point that made Village residents proud of what they had in this little place.

Here are excerpts from the application. The application contains photographs and a map of the area.

This is a district including portions of three blocks of brick buildings erected for commercial purposes near the railroad. Built over a period of nearly three decades, their appearance is nevertheless very harmonious and unified.

To the east along the south side of East Prospect, the buildings are fifteen years later.

Across First Street, at the east end of the district, another brick block serving as a warehouse is related in design to the Main Street blocks. Behind it rises a grain elevator, a large rectangular shaft with a gabled roof and a secondary shaft with its roof. Visually this structure forms the climax and the terminal to the entire district.

To the south of the railroad tracks is the Mantua Railroad Station.

The application was prepared by Eric Johanneson, Preservationist, at The

Western Reserve Historical Society, and approved by the National Park Service on December 24, 1974.

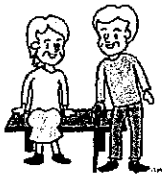
Then the river of time flowed on, and people forgot.

In Mantua Township, a group of residents chartered The Mantua Restoration Society, Inc. Their purpose was to raise money to help pay for badly needed renovations to the Township Hall and Civic Center. They did that, perhaps keeping the Township Hall from declining too far to save, and then the group went dormant.

The river of time flowed on, and people forgot.

In the Village, research about the relationship between a landmarks commission and certified local government, brought the National Register buildings back to light. In Mantua Township, the Friends of the School discovered the charter of the original restoration society, renewed the charter, and re-formed itself into The Mantua Restoration Society, Inc.

I don't know the person who did the hard work of getting the Village buildings onto the National Register. But I do know the charter members of the Restoration Society. The oldest are gone now. The youngest of them then were just over 30 to just over 35. Eric Hummel and Pat Magyarics were among them. That was 38 years ago, and you can do the math.



There's a lot of gray hair in the village and township governments, in the historical society and the restoration society, in the garden clubs, and in the service clubs that do so much so quietly that they may be unnoticed. Until they aren't here any more, that is. (By the way, there are good reasons why people governing probably *should* have the life experience that gray hair suggests. It's called wisdom, and it's not the same as being smart.)

We are all caught in the river of time, and it seems to me as if we stay in it with the same people we started with, and then there's a group behind us floating with *their* fellows. When the last of us in each group drops over the edge as if it were a waterfall, the people behind us forget.

We are in a very special time, right here, right now. In spite of all this gray hair, we are here, and we are working to build our places-village, township, historic buildings. What we also need to build is the lasting memory.

The Mantua Landmarks Commission is on the first leg of that, and the DMRC is further along organizationally, with less gray hair. But it will come.



What to do about that? The older ones need to reach back and grasp hands with the younger ones, and the younger ones need not only to take those hands, but also to reach back to those still younger. When we figure out how to do that, we will not be in a river any more. We will be knitting and weaving an enduring fabric. Doing that will take less thought and effort than the work defined by our mission statements, but it will take thought and effort.

Doing it will keep us from re-starting with every generation. It is worth it.

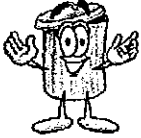
As you are keeping your own driveways and sidewalks clear this winter please remember that it is unlawful to plow, push or blow snow into our Village streets. You may need to remind contractors that you hire of this as well.



One more note for winter, please take precautions to ensure your pipes don't freeze. One trick during a cold snap is to open your sink cabinets so that heat is getting in to the pipes underneath. If you are still concerned you can leave the faucet dripping very slowly. Running water won't freeze easily. If you have

uninsulated pipes in the garage or basement you may want to put a space heater on low during the coldest days and nights.

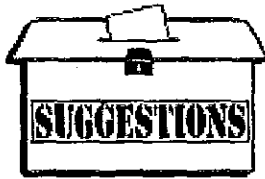
